BGHL is a closed-ended investment company which invests in BG Fund, Boussard & Gavaudan's flagship fund with 17 years of track record.

BGHL's investment objective is to deliver an annual return, net of fees, of 400 to 600 basis points above the risk-free rate over the business cycle, irrespective of market performance. The risk-free rate is "capitalized EONIA".

BG Fund is driven by bottom-up fundamental and event catalyst research, combined with extensive multi-asset arbitrage and derivative expertise. Typically, investment ideas are catalyst driven with a focus on special situations and events.

Capital is dynamically allocated to the firm's best ideas and these ideas are categorized into four main types of strategies: Equity, Volatility, Credit and Trading strategies.

HIGHLIGHTS

In July, the Euro Stoxx 50® total return index fell by -1.6%, while BG Fund (USD A class) gained +0.78% with the largest contributions coming from trading, risk arbitrage and credit special situation positions.

In terms of other market indicators volatility decreased moderately with VStoxx® finishing the month at 26.7%, down from 31.7%. Credit remained stable with iTraxx Crossover (S33) ® ending the month at 377bps (5bps tighter than June).

July saw varied risk-on/risk-off sentiment during the month, with some strong specific corporate earnings releases tempered by an uncertain macro backdrop with signs of a second Covid 19 wave in Europe starting to emerge, and fiscal stimulus and unemployment benefit schemes, scheduled to roll off in the Autumn, remaining under debate by policy makers.

Capital markets however have remained very active and we expect the core themes of refinancing, restructuring and balance-sheet strengthening to continue as corporates adjust to the new environment.

The portfolio is well invested in some very interesting opportunities and we are continuing to deploy capital into new positions. We continue to expect M&A to pick up and further new restructuring opportunities to emerge post-summer.
