Dorval Asset Management has on 31 May 2017 notified Ferratum that its holding of the shares and voting rights in Ferratum has as of 24 April 2017 exceeded the 5 % notification threshold.

Prior to the transaction Dorval Asset Managements holding in shares and voting rights in Ferratum Oyj was below 5 %.

Dorval Asset Management holds after the triggering transaction 1,105,012 shares and voting rights in Ferratum Oyj which represents 5.09 % of the company's shares and voting rights.
