The Annual General Meeting of Stolt-Nielsen Limited will be held on Tuesday, April 16, 2019 at 11:00 a.m. at the registered office of the Company at Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda. In this connection, the Audit Committee has recommended and the Board has proposed that PricewaterhouseCoopers LLP, London, be reappointed as the Independent Auditors of the Company. Consistent with the Company's Bye-Laws, it is requested that the Board of Directors be authorized to fix the remuneration of PricewaterhouseCoopers LLP.

Enclosed is the Notice of Annual General Meeting of the Company, together with a Proxy Card for your Common Shares to be represented at the Annual General Meeting. The Company has posted the 2018 Annual Report to Shareholders on the Company's website at <a href="www.stolt-nielsen.com">www.stolt-nielsen.com</a> under "Investor Relations" where shareholders may access the report. Included in the Annual Report to Shareholders are the Company's consolidated financial statements and unconsolidated financial statements as well as the Independent Auditors' reports relating thereto.
