

Oxurion Receives Transparency Notification from Atlas Special Opportunities LLC

Leuven, BELGIUM, Boston, MA, US – August 4, 2023 – 7.00 PM CET Oxurion NV (Euronext Brussels: OXUR) a biopharmaceutical company developing next generation standard of care ophthalmic therapies, with clinical stage assets in vascular retinal disorders, today announced that, pursuant to Belgian Transparency legislation¹ it has received a transparency notification as follows:

Oxurion received a transparency notification on August 2, 2023, from Atlas Special Opportunities, LLC indicating that as of July 27, 2023, it held 71,426,269 shares of the then outstanding 1,524,093,238 shares, and therefore crossed below the threshold (5%) by virtue of the acquisition and sale of voting securities. Oxurion (Euronext Brussels: OXUR) is a biopharmaceutical company developing next generation standard of care ophthalmic therapies, which are designed to improve and better preserve vision in patients with retinal disorders including diabetic macular edema (DME), the leading cause of vision loss in working-age people, as well as other conditions. Oxurion intends to play an important role in the treatment of retinal disorders, including the successful development of THR-149, its novel therapeutic for the treatment of DME. THR-149 is a potent plasma kallikrein inhibitor being developed as a potential new standard of care for the up to 50% of DME patients showing suboptimal response to anti-VEGF therapy.
