## Scandinavian Tobacco Group A/S - Reduction of share capital

On 4 April 2024, the annual general meeting of Scandinavian Tobacco Group A/S (the "Company") resolved to adopt a proposal by the Board of Directors to reduce the Company's share capital by nominally DKK 1,000,000 from nominally DKK 87,000,000 to nominally DKK 86,000,000 by cancelling some of the Company's treasury shares. Today the Board of Directors has resolved to complete the capital reduction, and the reduction of the share capital has been registered with the Danish Business Authority.

Following the capital reduction, the Company's share capital amounts to nominally DKK 86,000,000 divided into 86,000,000 shares of DKK 1 each. The total number of voting rights is 86,000,000.
