

Capital Increase in Genmab as a Result of Employee Warrant Exercise

Company Announcement

COPENHAGEN, Denmark; July 5, 2022 – <u>Genmab A/S</u> (Nasdaq: GMAB) will increase its share capital by 10,992 shares as a consequence of the exercise of employee warrants.

The increase is effected without any preemption rights for the existing shareholders of the company or others. The shares are subscribed in cash at the following price per share of nominally DKK 1:

500 shares at DKK 636.50, 491 shares at DKK 815.50, 2,750 shares at DKK 939.50, 782 shares at DKK 1,025.00, 200 shares at DKK 1,136.00, 320 shares at DKK 1,145.00, 5,129 shares at DKK 1,147.50, 167 shares at DKK 1,155.00, 211 shares at DKK 1,161.00, 178 shares at DKK 1,233.00, 164 shares at DKK 1,408.00, and 100 shares at DKK 1,432.00.

Proceeds to the company are approximately DKK 11.6 million. The increase corresponds to approximately 0.02% of the company's share capital.

The new shares are ordinary shares without any special rights and are freely transferable negotiable instruments. The new shares give rights to dividends and other rights in relation to the company as of subscription. The new shares will be listed on Nasdaq Copenhagen after registration with the Danish Business Authority. The capital increase is expected to be finalized shortly.

Pursuant to section 32 of the Danish Capital Markets Act No. 2014 of November 1, 2021, it is hereby announced, that the total nominal value of Genmab A/S' share capital after the capital increase is DKK 65,764,435 which is made up of 65,764,435 shares of a nominal value of DKK 1 each, corresponding to 65,764,435 votes.
