Eurocommercial joins the Euronext AMX[®] and AEX[®] ESG indices EPRA Best Practices Recommendations Awards 2022

Eurocommercial joins the Euronext AMX[®] and AEX[®] ESG indices

On 7 September 2022, Euronext announced the updated results of the quarterly review for AEX[®], AMX[®], AScX[®] and AEX[®] ESG indices, and we are pleased to report that Eurocommercial has been included in the composition of the AMX[®] and AEX[®] ESG indices.

The quarterly review result will be implemented after markets close on Friday 16 September 2022 and will be effective from Monday 19 September 2022 and as from Monday 19 September 2022, Eurocommercial will be included in both the AMX[®] and the AEX[®] ESG indices.

The AMX[®] index was launched in October 1995. It contains the 25 second largest and most actively traded companies listed on Euronext Amsterdam and is the most widely used mid cap indicator of the Dutch stock market.

The AEX[®] ESG index was launched in May 2022. It is designed to identify the 25 companies within the AEX[®] and AMX[®] indices demonstrating best Environmental, Social and Governance (ESG) practices and to facilitate the adoption of mainstream ESG investment approaches by institutional and private investors. The index selection is based on a starting universe of the 50 companies that make up of the AEX[®] and AMX[®] indices. From this universe, exclusions are carried out based on Sustainalytics data, and the 25 best scoring companies on ESG Risk rating are selected.

EPRA Best Practices Recommendations Awards 2022

We are pleased to announce that Eurocommercial has been awarded the EPRA* Financial Best Practice Recommendations (BPR) and Sustainability Best Practice Recommendations (sBPR) Gold Awards 2022.

The EPRA BPR and sBPR Gold Awards 2022 were based on the review of the 2021 Annual Report of Eurocommercial. EPRA sBPR is a sustainability reporting standard created by EPRA for listed Real Estate companies in Europe.

These awards clearly recognise the quality of the reporting provided by Eurocommercial to all its stakeholders both on ESG and financial matters.
