



Interinvest extends lease with ASML for Silver Forum, a site located on the premises of Eindhoven Airport

With this 10-year lease extension, one year before the actual end date of the contract, the occupancy rate of the Dutch portfolio remains 100%.

Interinvest Offices & Warehouses ('Interinvest') has signed with ASML, high-tech company, supplier of machines for the semiconductor industry used in making chips, a renewal of the existing lease. The property, known as Silver Forum on the site of Eindhoven Airport, has an area of 28,742 m². The existing lease commenced on 1 January 2015 for a term of 9 years and runs until 31 December 2023. The current lease extension commences on 1 January 2024 for 10 years, at market conditions.
