# Capital increase of 1,927 shares in Orphazyme A/S as a result of the exercise of Restricted Share Units

**Copenhagen, Denmark, April 23, 2020** – Orphazyme A/S (ORPHA.CO), a biopharmaceutical company pioneering Heat-Shock Protein response for the treatment of neurodegenerative orphan diseases, today announces that a share capital increase has been registered with the Danish Business Authority as a result of the exercise of Restricted Share Units by board members. A total of 1,927 shares of nominally DKK 1 each have been issued by the Company.

Reference is made to company announcement no. 31/2020 of April 22, 2020.

Following the share capital increase, the total nominal share capital will be DKK 27,044,929, divided into 27,044,929 shares each with a nominal value of DKK 1. Each share carries one vote at Orphazyme's general meetings and accordingly the total number of voting rights of the company are 27,044,929.
