## Publication of transparency notification(s) received by KBC Group NV

KBC Group NV has received a transparency notification on 15 November 2022, which states that FMR LLC has crossed the reporting threshold of 3% (total voting rights and equivalent financial instruments) downwards, to 2.97%.
