Assets under management (AUM) was 371.8 million USD.

The NAV per share in EUR, 2175.14, is calculated as the USD NAV divided by the EUR/USD exchange rate as of 31 July 2023 which was 1.1023.

To calculate the present EUR NAV, divide the most recent USD NAV with the current EUR/USD exchange rate.
