Van Lanschot Kempen: update on share buy-back programme 29 March 2022 – 4 April 2022

In the period from 29 March 2022 until 4 April 2022 Van Lanschot Kempen has repurchased 22,264 of its own shares (depositary receipts for Class A ordinary shares). The shares were repurchased at an average price of \pounds 24.44 per share for a total amount of \pounds 544,067.

These repurchases are part of the share buy-back programme for at most 600,000 of own shares, which was announced on 24 February 2022. The total number of shares repurchased to date is 166,938.
