WIND

- In June 2020, total wind production was significantly (28%) below expectations.
- Continuing lack of wind characterised the period, and production generated was 10% lower than the year-earlier period.
- Net wind production year-to-date was 36% below budget and 37% lower than the same period last year (excluding the assets sold in 2019).

SOLAR

- In June 2020, total solar production was 10% lower than budget and 8% lower than the year-earlier period.
- The average irradiation was 9% lower than expectations.
- Net solar production year-to-date was in line with expectations and 4% higher than the same period last year (excluding the assets sold in 2019).
