

February 2025 ETP Market Statistics

Amsterdam, the Netherlands - Flow Traders Ltd. (Euronext: FLOW) releases monthly ETP (Exchange Traded Products) market statistics for February 2025. This refers to general market observations only.

Highlights

- In February, On & Off Exchange Value Traded was up 39% y/y in EMEA, up 1% y/y in Americas, up 103% y/y in APAC, and up 14% y/y Globally.
- Quarter-to-date, On & Off Exchange Value Traded was up 39% y/y in EMEA, up 1% y/y in Americas, up 67% y/y in APAC, and up 11% y/y Globally.
- Average volatility, as exemplified by the VIX, was up 20% y/y in February and up 22% y/y quarter-to-date.
